It was resolved to accept the minutes of the meeting of the Parish Council of 3rd November 2009 subject to two clerical amendments.

Matters Raised by RFO (working papers had been provided by RFO)

The fact that the 2008 / 2009 Annual Return had been accepted by the Audit Commission and the comments therein were noted.

The RFO led a discussion on the financial budget performance for the current financial year. Following discussion this was accepted by the meeting.

The RFO led a discussion on the estimates for 2010 / 2011. After discussion, it was resolved to accept these figures and to set the precept for 2010 / 2011 at £51,861, a 2% increase.

The re-investment of reserves had been resolved in the Financial Authorisations above.

The RFO had provided evidence that the process was working satisfactorily to the Chair & the Clerk.

156/2009 Parish Council Processes

For the avoidance of doubt, it was resolved that both the Chair & the vice-Chair should automatically be ex-officio voting members of all council committees.

It was agreed that Cllrs Downing & Furness should attend the Planning Workshop on Saturday 5th December at PDNPA, Aldern House, Bakewell.

A report on the Power of Well Being training course on Monday 16th November at Chapel-en-le-Frith was provided by Cllrs Horstead & Nash. The benefits of Well Being were discussed. It was resolved that the council should take the steps necessary to qualify as a Well Being council.

The quotation received for provision of boundary microphones was discussed. It was noted that the acoustics of the Lounge were better than the Main Hall, and it was decided that the Lounge should therefore be used whenever possible.

157/2009 Village Issues / Initiatives

Due to the absence of PC I Richardson, the Clerk gave a verbal report.

The proposal by Derbyshire Constabulary that the council underwrites the cost of installing CCTV on a building on Netherside at a cost of around £350 was discussed. It was resolved, subject to the Police getting the agreement of residents on Netherside, to proceed with this request. The voting was

Cllr Downing gave a report on the current situation with the Youth Centre. The DCC supervisor is to raise the matter of improving the behaviour of the Youth Centre users at the next session. The option to provide 3 evenings of special activities for Youth Centre users is to be progressed by Cllr Walker. The need for a person to manage the volunteer rota and to carry out CRB checks was raised. The RFO is to take advice from DALC on how such role could be funded.

Cllr Horstead gave a report on the planning of Carnival 2010. The committee is planning to provide one Saturday event only.

The response from Derbyshire Fire & Rescue to the Clerk's letter enquiring about their plans for Bradwell fire station was read to the meeting. The content was positively received. The Clerk is to contact Derbyshire Fire & Rescue to offer space in Bradwell News to help recruit more local firemen.

The letter from Rebellion Knoll WI seeking use of a council marquee for Carnival 2010 was discussed. It was agreed to allow use of this marquee.

The letter from the St. Barnabas Church inviting the Parish Council to provide a Christmas tree as part of their Christmas Tree Festival was discussed. It was decided that the tree to be provided by the Carnival committee should be used to represent all council activities as well.

158/2009 Playing Fields & Village Caretaking

No monthly caretaking report was available due to the absence of the village caretaker.

Cllr Lawson gave a report on the recent meeting of the Playing Fields committee. Her report covered the many projects being planned for the playing fields including the a) TBPF football pitch, b) TBPF basketball court, c) TBPF Youth Shelter site, and d) provision of a specialist swing. It was decided that available options and costings for these projects should be included in a report to be tabled at the February meeting. Cllr Lawson is to contact Bradwell Sports Club to seek their support for these projects. It was noted that all these projects are in addition to the routine work carried out by the Caretaker and the work identified in the RoSPA report.

The Clerk is to contact Cllrs Eyre & Slater to confirm progress with plans for this year's Christmas trees and lights.

159/2009 Highways, Rights of Way & Open Spaces

Cllr Downing led a discussion on progress in establishing Parish Council allotments in Bradwell. No progress had been made with obtaining land from Lafarge. No response had been obtained from the land owner near Stretfield. The Clerk is to email him to remind him of the council's interest. No further response has been received from the owner of land on Town Lane. The Clerk is to write again in the New Year.

Cllr Furness gave a report on recent meetings about the Quarry. Two meetings had been held with PDNPA officers who agreed that this could be a good project. The success of this project would depend firstly on ensuring safe public access to the site.

The request from residents at Newwall Nook for a grit bin and the information provided by DCC was considered. It was decided that the council would request a grit bin to be provided subject to the residents identifying a suitable position for it. The Clerk is to progress this matter.
