PUBLIC PARTICIPATION

No matters were raised by the public.

116/2008 Apologies for Absence

Apologies were received from Cllr A Nash.

117/2008 Declaration of Members' Interests

Cllr J Walker declared a personal interest in the Planning Application for Outlands Head House.

118/2008 Acceptance & Signing of Previous Minutes and Matters Arising

It was resolved to accept the minutes of the Parish Council meeting of 12th August 2008. There were no matters arising.

It was resolved to bring forward item 6, monthly report from Derbyshire Constabulary, to allow PC P Whitehead to report and leave the meeting.

PC P Whitehead reported as follows:-

- He apologised for the lack of Police reports for the past few months.
- 11 crimes had been reported, 4 of theft, 4 of violence, 2 of damage and 1 dropped charge.
- 13 calls for service, e.g. nuisance, parking, residential issues.
- Regarding the council priorities, the Police regularly attend the Youth Centre and they are having difficulty in monitoring speeding through the village due to lack of access to a speed gun.

It was resolved to continue business as per the agenda.

It was resolved to authorise all the above financial transactions.

Other Financial Matters

The RFO reported that the Youth Centre PC together with two metal / glass bus shelters have now been included in the insurance policy. The remaining brick bus shelter will be insured once he has obtained an estimate for the re-build cost.

The RFO gave a financial overview of the running of Carnival 2008. Overall, it has made a profit, had been successful and those involved are to be applauded.

The increase, from 1st September 2008, in room hire charges for the Methodist Hall & Methodist Lounge were noted.

The letter from the Well Dressing Committee was considered. It was resolved that the Clerk should write to the Well Dressing committee to advise a) that they should return the balance of £150 and b) that the request for a donation of £150 towards the cost of the new clay is to be granted.

121/2008 Village Issues / Initiatives

Cllr Slater gave a non-financial review on the running of Carnival 2008. He stated that a) he would not run Carnival 2009, b) the transfer back to Beggars Plot was welcomed by all, c) a review would be placed in Bradwell News, d) all involved had made it a success, e) both Saturday events had been a great success.

Cllr Furness gave a general update on progress of the Newburgh proposals. He stated that the Newburgh Planning Application is expected in October. The main issue is how best to obtain the views of the people of the village. It is proposed to hold a referendum, preceded by public session where the plans will be made available for inspection and query. It is important to ensure that all villagers are informed of this process. This last aspect was discussed.

It was resolved to suspend Standing Orders to allow Mr Emsen to address the council.

Mr Emsen advised the council on what the distributors of Bradwell News could do to help.

It was resolved to re-instate Standing Orders.

It was agreed that the Newburgh Referendum working group of Cllrs. Downing, Furness, Lawson, Nash and Slater should progress this matter.

Cllr Downing gave a general update on the Youth Centre. He stated that the Youth Centre had been through a difficult time, but he was optimistic that the Centre would settle down. The position of co-ordinator has been advertised and one applicant already interviewed.

Some volunteers had attended the last committee meeting and had contributed greatly to discussion.

Cllr Furness gave a general update on the last Rights of Way and Common Lands committee meeting. Cllr B Hardy is relocating to Buxton and has resigned from both the council and this committee. Cllr Furness thanked Cllr Hardy for his contribution to this committee. A vacancy now exists and other councillors were invited to apply.

Cllr Furness included updates on the claim for adverse possession of Dale End, the Yeld footpath, and the two issues at Wortley Court.

Regarding the proposed DCC Stopping-Up Order to property adjacent to 'The Shoulder', the committee's recommendation that no change should be made to the previous stance was accepted by the council, and the Clerk was asked to write to DCC to advise that the council did not agree to their request.

The letter from PC D Eyre was considered. The Clerk was asked to write to PC D Eyre thanking him for his work.

122/2008 Playing Fields & Village Caretaking

The Caretaker was not present so no report was available.

The electric supply for the Christmas Tree at the Peace Gardens was considered. The Clerk was asked to investigate further.

123/2008 Highways, Rights of Way & Open Spaces

Cllr Furness gave an update on progress of the possible Traffic Regulation Order for Brough Lane. He stated that we would know on 5th September whether our letter had been effective and the lanes were to be included on the agenda for 12th September. Plans would be made at the meeting of the TRO Working Group on Monday 8th September.

The petition about car parking on Wortley Court was discussed. It was resolved to defer this matter until the other issue on Wortley Court has been concluded. The Clerk is to write to the residents to inform them.

The East Midlands Regional Plan (Regional Spatial Strategy) was discussed and it was decided not to respond to this document.
