It was resolved to authorise all the above payments.

#### **Other Financial Matters**

The insurance quotation to include further parish assets on the existing policy was reviewed. The quotation for including the Youth Shelter and the Youth Centre assets was £117. The RFO was asked to obtain a further quotation for the inclusion of the new Youth Centre PCs and the bus shelters, but parish benches are to be excluded.

The outcome of the meeting with St Barnabas PCC for a S137 grant towards the refurbishment / improvement of the Church Clock was discussed. The Clerk was asked to write to the PCC asking them to obtain a quotation for the refurbishment of the carillon and then to discuss this with the Parish Council.

The application from the Bradwell Centenary Players for a S137 donation of £350 towards the cost of around £1,000 for a new piano in the Bradwell War Memorial Hall was discussed. It was decided to make the £350 award to them.

The deferred request from the Open Spaces Society for a donation was considered. It was decided not to make a donation at this time.

The application from Vitalise, an organisation providing holidays for disabled people and their carers, for a donation was considered. It was decided not to make a donation at this time.

The application from Victim Support Derbyshire, an organisation providing support to victims and witnesses, for a donation was considered. It was decided not to make a donation at this time.

#### 081/2008 Parish Council Processes

The Terms of Reference for the six PC committees were reviewed. It was resolved to adopt these for the coming year, subject to small changes to the Youth Centre committee Terms of Reference to be agreed with Cllr Downing.

The Terms of Reference of the Youth Club Management sub-committee are to be agreed at the next meeting of the Youth Centre committee.

The appointment of members to the Carnival committee was reviewed and no changes were agreed.

The need for a separate committee to address the issues associated with the impact of motorised vehicles on Brough Lane / Bradwell Edge was discussed. It was resolved that a) Bradwell Parish Council should form a working group and invite Brough & Shatton and Eyam parishes to join the group and b) that Cllrs Downing, Eyre, Furness and Hardy together with Mr J Riddall be appointed to this group.

An update on the recruitment of a Cleaner for the Youth Centre was provided by the Clerk. The position has been advertised and a decision will be taken after the closing date.

An update on the co-option of a new councillor was provided by the Clerk. The position has been advertised and a decision will be taken after the closing date.

An update on expenses which are available to members was provided. DDDC had convened a meeting of their Independent Review Panel and the Clerk will advise the council once he has that report.

#### 082/2008 Village Issues / Initiatives

A general update on progress with the Youth Centre was provided by Cllr Downing. He reported that the separate roles of the Youth Centre Committee (YCC) and the Youth Club Management sub-committee (YCMC) and the way of handling of finances have been agreed.

Cllr Furness provided a general update on progress of the Newburgh proposals.

Cllr Furness provided a general update on progress with Rights of Way and Common Lands committee. He reported that the adverse possession of the Dale End plot was progressing and a tree officer has inspected the plot.

Cllr Slater provided a general update on progress with the planning of the Carnival. He reported that the overall planned expenditure is within the budget provided by the council and that the planning of the evening entertainment for the second Saturday is going well.

No report was available from PC D Eyre / PCSO A Boswell.

#### 083/2008 Playing Fields & Village Caretaking

Village Caretaker, Brian Nicols, gave his monthly progress report. He reported that besides his routine work of litter collecting, he has been involved in strimming the grass and preparing flower tubs ready for planting. He now planned to repair the wall overlooking the brook at Town Bottom Playing Field.

Both Cllr Hardy and Brian Nicols left the meeting at this point.

Cllr Furness provided a general update on progress with litter picking around the village. He reported that Lafarge has provided 24 sets of litter pickers and they would now like a publicity photograph to high-light this activity. The Clerk was asked to write a letter of thanks to Lafarge and also to Mrs Maskrey for her efforts in organising the litter picking rotas.
