LPF – 34/2022 Review the report detailing a plan for the development, maintenance, and use of The Dumbles

The plan for the development, maintenance, and use of The Dumbles was reviewed. It was resolved that a drainage channel needs to be installed. One quote is available, but three quotes are required to comply with councils financial regulations.

It was resolved to install CCTV cameras onto the Dumbles and write to people who have authorised agricultural access when they are installed. The clerk advised the committee that all people who have authorised agricultural access have already been informed that the parish council are considering the installation of CCTV on the Dumbles.

The committee were advised that Camstead are still waiting for some issues to be resolved with Peak Park Angling Group before the pedestrian bridge can be installed.

It was resolved to ask Derbyshire Dales District Council to put a rubbish bin beside the bridge when it is installed.
