# <u>Minutes of the</u> <u>Meeting of the Parish Council</u> <u>held at 7:30 p.m. on Tuesday 6<sup>th</sup> December 2022.</u>

# PUBLIC PARTICIPATION.

A couple of residents attended the meeting to advise council that they had written to Peak District National Park Authority to complain about the changes made to two properties on Bradwell Springs which are being used as holiday lets. Their belief is that these changes contravene a covenant in the purchase contracts for the houses. They also advised that one house has converted their garage into a games room, and another has installed a hot tub in the garden, both of which contravene planning regulations. They have also written to Sarah Dines MP to request that she supports the bill going through parliament to restrict the number of homes being converted into holiday lets. The residents advised that they are taking this course of action as they are concerned that the village could lose its community feel and spirit if too many houses are converted into holiday lets.

Cllr Granger advised the residents that the issue of the number of holiday lets in the Peak District is on the agenda to be discussed at the Peak Park Parishes Forum.

As advised at previous council meetings County Councillor (CC) Sutton is currently unable to attend the parish council meetings therefore it was agreed that some councillors would meet with him prior to the monthly parish council meeting and give a report from that meeting.

Cllr Granger reported the following from that meeting:-

- CC Sutton advised that he has written to the new contact at the Environment Agency and given them a number of possible dates for a meeting between the Environment Agency, Derbyshire County Council, Bradwell parish council and Peak Forest Angling Club to discuss the flooding in the village and what can be done at the brook to increase the flow of water when there is excessive rain
- CC Sutton also advised that he has a sum of money which can be distributed to aid wellbeing in the community
- CC Sutton also advised that there should be a grant available for some new village signs.

District Councillor Furness asked for an update on what was happening with the BOAT (Byway Open to All Traffic) application on Moorbrook Lane and New Lane. Council advised District Councillor Furness that this was on the agenda and would be considered later in the meeting. District Councillor Furness reminded council that it was Derbyshire County Council responsibility to clean up if any stones or rubble are washed from Moorbrook Lane down into the village as happened in 2021.

# Parish Issues / Initiatives

# 254/2022

Cllr Nash reported the following from the Land and Playing Fields committee

- Installation of the new play equipment on Beggars Plot playing field is in progress with the opening on Monday 12<sup>th</sup> of December attended by the children from the school
- New Christmas lights have been installed on the tree at the end of Main Road and the lights on the hedge at Beggars Plot playing field are planned to be installed in the beginning of December
- The contract to allow the pedestrian bridge to be installed on the Dumbles is expected to be completed in December 2022
- Some quotes have been obtained for the installation of a drainage grid on the Dumbles an additional quote is required before the work can commence
- The CCTV sign which was agreed at a previous meeting will be installed in December 2022

#### 255/2022

In the absence of CIIr Salvage the clerk reported that a review of the 2022 carnival had taken place. A number of improvements were identified, and the committee agreed to incorporate them into the planning of the 2023 carnival. Council was advised that planning of the 2023 carnival will commence with a meeting on 15th February 2023

#### 256/2022

Cllr Salisbury presented a proposal from the Community Resilience committee that council purchase a powered wheelbarrow to aid in the distribution of bags of salt in order to salt the pavements. Council **resolved** to purchase the wheelbarrow. Cllr Salisbury also advised that a salt spreader had been purchased and this was now in the store at Town Bottom playing fields.

Council was also advised that the pull along barrow was broken and needed to be welded. Cllr Harrison has agreed to complete this repair.

#### 257/2022

It was **resolved** to post about the following items on Council Facebook page as soon as they have been completed

- New play equipment at Beggars plot playing field
- Christmas lights in the village
- Pedestrian bridge from Bradwell Springs to Softwater lane
- Happy Christmas post from council

# 258/2022

Council considered a proposal that we write to Peak District National Park Planning Authority to support the residents of Bradwell Springs, Bradwell in their complaint that some houses in Bradwell Springs are being advertised as holiday lets. Council **resolved** to carry out the following actions

- Council to write to Peak District National Park Planning Authority to advise that there may be planning infringements on a couple of properties on Bradwell Springs namely the conversion of a garage to a games room in one property and the installation of a hot tub and an associated structure in the garden of a second property.
- Council to write to Camstead, who built the houses in Bradwell Springs, to ask if there is a covenant in the deeds of the houses which prevents the houses being used as businesses. Two houses have been set up as businesses which resident believe break this covenant

# 259/2022

Council considered the next steps on the BOAT (Byway Open to All Traffic) application for Moorbrook Lane and New Lane. Council was advised that the application was submitted over eighteen years ago. It was resolved to monitor the situation and revisit the subject if any additional information on the application is received. It was resolved to write to communicate this decision to a resident, who has been in contact with the council.

**ACTION:** Clerk to write to a resident advising them of councils decision

#### 260/2022

Cllr Nash gave council an update on providing a warm space for residents in the village during winter months. He advised that the space is open in St Barnabas Church, and the opening times have been advertised in the village and on Facebook. Thanks were given to Derbyshire County Council, Derbyshire Dales District Council and the Co-op for their donations which have allowed the space to be set up

# Parish Playing Fields, Open Spaces and Village Caretaking

#### 261/2022

The clerk advised that there is no further progress on the lease agreement for the toilet block with Severn Trent Water. It was **resolved** that the clerk is to continue to chase the solicitors to complete the lease.

#### 262/2022

The clerk advised that there is no further progress with the solicitors acting for The Guinness Partnership. It was **resolved** that the clerk continues to progress transfer of the land to Bradwell parish council

The clerk advised that a report went to the G&R Committee at Derbyshire Dales District Council on 22 November 2022 and the recommendation the transfer of Grey Ditch to Bradwell Parish Council was passed. The issue is now with the legal team so the process of transfer can be completed.
